

Chinese imports of copper scrap in July up by 37% MOM


BEIJING (Asian Metal) 26 Aug 14 - The Latest data from China Customs showed that Chinese imports of copper scrap stood at 360,010t in July, up by 37% month-on-month and up by 3% year-on-year.



Due to the shipping schedule, copper scrap delivery usually lags two months behind. In May, copper prices in London and Shanghai increased, and the arbitrage window opened again. Moreover, Chinese imports of copper and copper concentrate declined in July, and copper scrap supply in the domestic market was tight. Therefore, copper scrap imports rebounded sharply in July. The following picture showed Chinese price trend of bare bright copper wire in May-Jul (RMB/t):



In the first seven months of 2014, Chinese imports of copper scraps amounted to 2.12 million tons, down by 12% year-on-year. Due to the unfavorable arbitrage, Chinese buyers reduced imports.



The United States, Hong Kong and Australia were still the top three exporters to China, and the export volumes were 71,965t, 66,242t and 39,451t respectively in July.
